## Scholarship Application 2012 – 2013

\*\*\*\*Application due September 28, 2012\*\*\*\*

*This Scholarship program is offered to accommodate potential dance students who would be unable to participate in our program due to financial hardships. The Danceability Scholarships provides reduced or no fees for those who qualify based upon family income; having more than one family member with special needs; single parent family; extraordinary medical needs; catastrophic events or special family circumstances.*

### **Please review the following Scholarship Application Eligibility Guidelines:**

- 1.) Scholarships will be awarded based upon the demonstrated need and the availability of funds.
- 2.) Amount of fees waived will be based on income criteria and household size and the assessment of special situations.
- 3.) All applicant information is confidential and not a matter of public record.
- 4.) All applicant information must be true and accurate.
- 5.) Proof of financial need must be presented by submitting your most recent Federal Income Tax Return (Form 1040 or Form 1040 A) and corresponding W-2 or 1099 earnings summaries. If applicant is not required to file an income tax return, then additional documentation is required (see below).
- 6.) Scholarships will not be reviewed and awarded unless the application form is completely filled out, properly submitted by the due date stated on the form.
- 7.) It is expected that dancers awarded scholarships will fully participate in the *danceability* program and attend all classes unless the dancer is unable to do so due to a medical condition or special circumstance.

### **Additional Documentation Required When Applicant has No Federal Income Tax Return & W-2 Forms:**

Applicants who are exempt from filing a Federal Income Tax Return or are unable to provide corresponding statement of income, must provide copies of the following applicable documentation for all household members in order to be considered for tuition waivers:

- 1.) Checking and Savings account statements for previous two months.
- 2.) SSA / SSI Award Letter (Disability Income).
- 3.) Proof of unemployment benefits for previous two months indicating amounts received.
- 4.) Proof of Application for/or Receipt of Benefits from Public Aid or Food Stamps
- 5.) Workman's Compensation for previous two months indicating amounts received.
- 6.) Copy of Divorce Decree including alimony and child support amounts.
- 7.) Other relevant documentation.

\*\*\*Partial Scholarships will be awarded in October in the amount of **\$165.00 TO BE USED FOR THE FINAL TRIMESTER PAYMENT.**

\*\*\*Full scholarships will also be awarded as funds become available according to donor criteria.
